away in the summer. You will receive a fresh bouquet starting on August 31<sup>st</sup> through September and,  
depending on Mother Nature, either a fresh bouquet or a seasonal dried bouquet for October and  
November.]

\_\_\_\_\_ **Full Season Share:** 20 weeks / \$ 240. July 6<sup>th</sup> - November 16<sup>th</sup> [Tuesday delivery]  
[The 'Full Season Share' is a weekly bouquet from July thru November. The CSA member will receive  
our farm fresh bouquet July, August and September and either a fresh bouquet or a seasonal dried bouquet  
for October and November. Our seasonal dried bouquets consist of flowers, herbs and ornamentals that  
we have selectively harvested and dried throughout the season.] \*\*Plus 1 free bonus holiday bouquet on  
the final delivery day!
